



expansion in provider membership and scope/expertise beyond IDD):



1. In 2023, the Alliance BOD expanded the voting membership to include not only PASAs and CCBs, but also CMAs. In Phase II of Evolution of Alliance, we are discussing if the scope and expertise should expand beyond IDD and if we should allow non-IDD providers into membership. What would you like to see for the future of Alliance? (Single choice) \*

#### 51/51 (100)% answered

Continue to only represent IDD providers (PASAs), Early Intervention Brokers, and CMAs and only work on IDD-related policies. (Stay the 11/51 (22)% same.)

Continue to only represent IDD providers (PASAs), Early Intervention Brokers, and CMAs and EXPAND Alliance's scope and expertise to 21/51 (41)% include all HCBS Waivers for case management work. (Expand scope and expertise to all waivers for case management only.)

EXPAND membership to more HCBS providers, Early Intervention Brokers, and CMAs and EXPAND Alliance's scope and expertise to 17/51 (33)% include all HCBS waivers. (Expand membership and scope and expertise to all HCBS waivers.)

EXPAND to go beyond HCBS and become an association for any Medicaid provider. (Expand membership and scope and expertise to all 2/51 (4)% Medicaid.)

#### Evolution of Alliance DRAFT Timeline

- 2024-25
  - Scope of expertise: No change
  - Scope of membership: Consider adding "El Brokers."
  - Staff capacity: Explore purchasing association management software.
- 2025-26
  - Scope of expertise: Explore expanding to all waivers for CMAs.
  - Scope of membership: Consider adding "El Providers."
  - Staff capacity: Explore adding CMA/EI expertise with a contractor or additional staff.
- 2026-27.
  - Scope of expertise: Explore expanding to all waivers for all members in 2026-27.
  - Scope of membership: Consider adding LTSS Providers.
  - Staff capacity: TBD

NOTE: New rules are replacing "Program Approved Service Agency" with "Provider Agency" so we will likely need to change our bylaws in 2024.



April 18, 2024 2024 <u>Alliance Bylaw</u> Updates

#### MEMBERS OF THE CORPORATION:

#### Section 1: Members

Any state-approved Community Centered Board, Program Approved Service Agency, and Case Management Agency operating within the borders of the State of Colorado and serving persons with intellectual and developmental disabilities shall be eligible for membership. Members shall consist of Community Centered Boards, Program Approved Service Agencies and Case Management Agencies that are in good standing ("Member"). A Member in good standing is a Community Centered Board, Program Approved Service Agency, or Case Management Agency currently registered by the Office of the Secretary of the State of Colorado and in good standing with the Colorado Department of Health Care Policy and Financing, Division for Intellectual and Developmental Disabilities, or any succeeding state entity or authority. Applicants for membership to the Corporation shall be accepted for membership upon a vote for acceptance by a quorum of the Board of Directors.

Proposed: Any state-approved provider of services, case management, or service coordination operating within the borders of the State of Colorado and serving persons with intellectual and developmental disabilities or delays shall be eligible for membership.

• Amend the remaining language accordingly, removing the reference to the Division for IDD.

Alliance DRAFT Budget and Dues Adjustment Update (Hoping to finalize with the Alliance BOD in May 2024)

- Alliance Draft Budget
  - Alliance 2024-25 budget maintains operational expenses at 2023-24 levels.
  - Includes staff salary survey adjustments and cost of living increases.
  - Revenue increases from new membership dues and the Alliance Summit.
- Alliance Dues Adjustment
  - This draft budget includes an average 3% dues increase for membership. The dues adjustments account for changes in individual agency budgets, so changes to dues seen by member agencies will vary.
  - Due to CMRD, some agencies will see some big shits in revenue/dues. (-27% to +47%)
