# Housing Voucher Overview

#### What are they?

- HUD-funded Housing Choice Vouchers (Section 8) are the primary, but not only, kind of housing voucher
- Subsidizes a portion of monthly rent and utilities
- Generally tenants pay 30-40% of the household's adjusted gross income
- Voucher payment is limited by the "Payment Standard" (based on Fair Market Rent for the area)
- Units must pass inspection
- Can be used in virtually any rental unit
- Operated by many different housing authorities (<u>www.hud.gov/states/colorado/renting/hawebsites</u>)
- DOLA/DOH subcontracts with 53 different local organizations to help administer our vouchers around CO

# Housing Voucher Overview

#### How do I get a housing voucher?

- Most voucher programs have long waiting lists, so they only open them for short periods
- Reach out to every housing authority (or DOH contractor) in the area that you live, or want to live
- Each HA will have their own process for advertising when their waiting lists are open for new applications
- Each HA will also have their own priorities

#### Once you are offered a voucher -

- Be prepared to provide backup documentation ID + all income & assets for every household member
- Attend Voucher Orientation/Briefing
- Search quickly you only have 120 days to find a unit (can make a Reasonable Accommodation request for more time)

Started as a partnership with HCPF/Medicaid in support of a federal demonstration program, Money Follows the Person

- Originally called Colorado Choice Transitions (CCT)
- Became Targeted Case Management Transition
  Coordination (TCM-TC) in 2019, & a permanent part of Medicaid's State Plan
- For people exiting institutions who are using TCM-TC services and are eligible for Home and Community Based Services (HCBS) waivers
- TCM-TC services help people plan their move out of the institution and into the community, including applying for a housing voucher and setting up in-home care
- TCM-TC services also include Housing Navigation services, to help people find a home to rent.

Expanded to work with HCPF/Medicaid's Supported Living Services (SLS) Waiver Exception services

- Designed to reduce the waiting list for the Developmental Disability (DD) waiver
- For people enrolled in the SLS waiver who
  - Request an Emergency Enrollment to the DD waiver
  - Are homeless or at-risk of homelessness
  - Could be supported by SLS Exception services to continue to live independently
- Does not include Transition Coordination or Housing Navigation services
- To apply, contact your HCBS case management agency.
  Their designated Emergency Enrollment contact would send a request to HCPF's Emergency in-box

Guided by Housing Choice Voucher regulations, but...

- State-funded
- No background checks for the member (do check live-in aides and anyone added to the household later)
- Do not have to be lawfully present in the U.S.
- More flexibility on vital documents to establish the members' identity and age
- Birth certificate not required (but strongly recommended), so long as photo ID displays age
- Can pay security deposits, up to two months of rent
- No minimum rent (HCV minimum is \$25/month)
- Cannot use the voucher outside of Colorado

To apply, contact your HCBS case management agency. Their designated Emergency Enrollment contact would send a request to HCPF's Emergency in-box with:

- Member name & SSN
- Case Manager name & contact info
- Release of Information for DOLA/DOH signed by member or guardian
- Statement explaining the member's housing situation, why they are homeless or at-risk
- Confirmation of enrollment in SLS
- Confirmation that the 100.2 Assessment is complete
- Confirmation that the Interdisciplinary Team has documented that independent living is feasible

HCPF will send DOLA/DOH's CATeam an email referring the member to a voucher

Complete your application to DOLA/DOH's CATeam with:

- Application form (will be attached to referral email sent from HCPF to DOLA)
- Verification of Disability form (in the application)
- For every household member over 18:
  - Government issued & currently valid photo ID
  - Social Security card (or Proof of Order within last 60 days)
  - Proof of income & assets, dated within last 60 days
  - Birth certificates or Proof of Order (not required by DOLA, but strongly encouraged as many landlords ask for them)

# Section 811 Project Rental Assistance (PRA)

Federal grant for project-based subsidies in integrated housing

- 1st award helped create 91 units in 7 projects
- 2nd award will help create about 80 units

#### Serves

- Non-elderly disabled (under 62)
- Same priorities as CAT Vouchers

#### DOH's role

- Selects projects
- Refers eligible tenants & administers "vouchers"
- Monitors projects
